Conduct Inquest in Death Wilkes Man

Millard Walker Smith Passed Away At State Road Home Monday Last Week

Coroner Stephen A. Rash was called to State Road on Monlay of last week to investigate the death of Millard Walker Smith, age 45, who died at the home of John Kennedy there. After hearing the evidence the coroner's jury rendered a verdict of "death by acute alcoholism."

According to evidence presented, Smith, who had been making his home at State Road, visited the Kennedy home Sunday night. According to the Kennedys he spent the night, arising about three o'clock Monday morning. It was said he built a fire and sat down in a chair where he remained until about six o'clock when he suddenly pitched forward into the floor.

Members of the family were said to have picked him up and placed him upon a bed. They said he appeared to be sleeping. and that they left him and went to the barn to milk. It was upon returning from the barn that they found Smith to be dead.

The coroner's jury was empaneled when it was suggested the dead man might have been drinking poison whisky, and Dr. Hugh Parks, Elkin physician, was called in to make an examination. However, due to the fact that no autopsy was held, it was found impossible to determine if this was the case.

It was said Smith had been drinking prior to his death.

Funeral services for the ceased were held Tuesday afternoon from the State Road Baptist church in charge of Rev. Grant Cothren. The widow and seven children survive.
