Mrs. Clarence Call Claimed By Death

Funeral Service For Well Known Local Woman To Be Held Friday, 3 P.M.

Mrs. Clarence Call, member of one of northwestern North Carolina's best known families, died at 8 a. m. this morning at Wilkes hospital.

Mrs. Call, who had been making her home in North Wilkesboro and in Greensboro, was spending the winter at Hotel Wilkes here. Several days ago she became ill and yesterday her condition became serious and she was taken to the Wilkes hospital, where she died this morning.

Mrs. Call, who before her marriage was Miss Sallie Cook, was born in Guilford county, a daughter of the late Thomas A. Cook and Mrs. Goazel Rhodes Cook, of Friendship. She was married to Clarence Call, who for many years was one of North Carolina's outstanding business men and who held the office of sheriff of Wilkes county. He died several years ago.

Surviving Mrs. Call are three daughters: Mrs. John E. Justice, Jr., of North Wilkesboro; Mrs. Orten Boren, of Greensboro; and Mrs. J. B. Carter, of North Wilkesboro. Also surviving are two sisters, Mrs. G. S. Boren and Mrs. W. M. Hunt, of Greensboro.

Funeral service will be held Friday afternoon, 3 o'clock, at the home of Mrs. J. B. Carter, on Ninth street. Dr. Gilbert R. Combs, pastor of the North Wilkesboro First Methodist church, of which Mrs. Call was a member, and Rev. J. H. Armbrust, a former pastor, now superintendent of the Statesville district of the Methodist church, will conduct the service. Burial will be in the family plot in Mountain Park cemetery in Wilkesboro.

School Building Needs Listed For Remainder Area

Supt. Eller Completes Summary Of Needs For Buildings And Additions

In this article, the last of a series of three articles on needs for new and enlarged school buildings in Wilkes county is being published. These articles were written by C. B. Eller, county schools superintendent, and he will also supply articles dealing with needs for school buses and for vocational departments in the county high schools.

DISTRICT NO. SEVEN Ronda School

The Ronda school needs a 12-room elementary building with cafeteria and large auditorium for use by the entire school.

The present building should be remodeled to house the high school and eighth grade.

This school needs an addition of two toilets, plumbing and sewage disposal system.

Clingman School. Clingman school needs additional class rooms to take care of the students of that district and Dennyville. There should be added two toilets, plumbing, central heating and sewage disposal system.

Pleasant Hill School. The school needs a new building containing eight class rooms, library, cafeteria and auditorium. Four rooms of the present building could be used for some time, but it is not desirable.

The school needs central heating, plumbing and sewage disposal system.

Pleasant Ridge School. This would be an outright new unit to house the students now in Pleasant Ridge and Mine Ridge schools and also the students now living in the district but attending school in Surry county.

This building should have at least five rooms, library, cafeteria and auditorium. It should be equipped with new furniture, water system, central heating, plumbing and sewage disposal system.

DISTRICT NO. EIGHT Roaring River School. The Roaring River school should have a building to house the elementary school. It would take a building with 12 class rooms, cafeteria, and large auditorium.

The present building should be remodeled and used to house the high school.

The school needs a new water and sewage disposal system.

COLORADO SCHOOL Lincoln Heights School. The Lincoln Heights school needs a building with 10 class rooms and auditorium to house the elementary grades and the students now in Ronda and Trap-hill colored schools. This building should be a complete unit with central heat, water and plumbing.

The present building should be renovated to house the high school. It should have added central heating, plumbing and sewage disposal system.

Thankful School. There should be built a Thankful elementary building large enough to house the students in that section. This building should contain modern conveniences.

Timber Thinning Demonstrations Feb. 25th-26th

On February 25 and 26 Carl W. Strauss, of the U. S. Forest Service, and R. W. Graeber, State Extension Forester, will be in Wilkes county to conduct demonstrations in thinning timber and in timber stand improvement.

The first demonstration to be held in this county will be in the afternoon of Monday, February 25, at 2 p. m. This demonstration, showing the correct way to thin pine timber, will be conducted in the woodlands of Miss Nina Sales, on U. S. Highway 421, about 11 miles east of Wilkesboro. Timber growing in thick stands tends to stagnate and, unless properly thinned, the owner loses a great deal of wood growth. By properly thinning such a stand the growth of timber is greatly stimulated and considerably more wood can be grown to the acre. All owners of young timber should attend this demonstration.

The second demonstration is to be held at Mr. Coy Eller's farm, which is on U. S. Highway 421, about 16 miles west of North Wilkesboro. This demonstration is to be on timber stand improvement. Large areas in this county are in need of this type of improvement before good high quality timber can be grown. Woodlands containing a large amount of "culled" trees interfering with the younger growth trying to grow underneath needs this type of attention before the young growth is killed out or grows into crooked trees. All owners of this type of woodlands are urged to attend this demonstration, which will be held the morning of February 26, at 10 o'clock.

Cravens, Parents Of 14, Married 50 Years Feb. 19

Mr. and Mrs. Sam Craven, who reared 14 sons and daughters, on Tuesday observed their fiftieth wedding anniversary.

Mr. Craven and Miss Myrtle Sloope were married in North Wilkesboro on February 19, 1896, and with the exception of about two years spent in Elkin have made their home here since that time. For the past 28 years he has been in charge of the pump station for the North Wilkesboro water supply system.

Mr. and Mrs. Craven reared all their 14 sons and daughters to adulthood, and the only two deaths were by accidental means. Joe Craven died of burns here several years ago, and Sgt. Don Craven, in the Marine Corps on Okinawa, was killed when a gun accidentally discharged in the hands of a comrade. For their fiftieth wedding anniversary Mr. and Mrs. Craven spent a quiet day at home. They did not care for a celebration of the event without their children, some of whom are at distant points and would not have been able to attend.

Committees Were In Many Activities During Past Year

Schools Enrolled 100 Per Cent In Junior Red Cross; Chairmen Appointed

At the annual meeting of the Wilkes County Chapter of the American Red Cross on February 11, 1946, the various standing committees gave interesting reports of their work during 1945.

Mrs. Richard Finley, chairman of the Camp and Hospital Committee, reported that the local chapter is a member of the Piedmont Camp and Hospital Council, convalescent hospital at Camp Butler and the hospital at overseas replacement depot being especially assigned to this chapter for service. From time to time the chapter is asked to provide articles not furnished by the army which add to the comfort and morale of patients. For their Halloween parties the committee sent 100 false faces, 100 favors, and 25 fancy hats. Articles furnished for Christmas included one lot of Christmas tree decorations, Christmas wrappings, pointsettia plants, wreaths, 12 yards satin ribbon, four boxes playing cards, 10-pound fruit cake, five boxes candy, 100 tray favors and one lot presents. Through this committee many private individuals donated 102 Christmas gifts and one radio; the North Wilkesboro Woman's Club, 100 homemade cookies; while the American Legion and Auxiliary gave six new radios for use on wards. During February 5 new Victrola records were also sent.

The Junior Red Cross membership drive was conducted in November and every school in Wilkes county was enrolled, the Juniors paying from their own funds the enrollment fees for the few small schools which did not enroll voluntarily. Total amount contributed by the school children was \$452.23. One of the big activities during the year was the filling of 154 Christmas gift boxes to be distributed to children in war-torn areas. Other articles produced by Junior Red Cross members includes 28 Christmas mena covers for the navy, 150 tray favors for hospitalized patients, 51 crossword puzzles. In addition Juniors contributed 14 pocket-size novels, \$10 worth of Christmas gifts to the Camp and Hospital Council collection, and 80 pairs of socks for the N. C. police hospital.
