

## **Applications For Cotton Insurance Now Under Way**

Farmers in Wilkes County were urged today not to let the time slip up on them in filing applications for cotton crop insurance. The closing date for accepting applications is April 10. or seeding time, which ever is earlier, according to H. C. Roberts, Chairman of the AAA County Committee.

There's a double reason for farmers to get their applications in early, he explained. One reason is for each farmer individually to have protection against all unavoidable natural hazards, which only Federal Crop Insurance can give him. Insurance protection starts when the cotton protection starts when the cotton is planted.

The other reason is much the same, only broader-to make sure that the county has the required number of growers cooperating in the insurance program. Before crop insurance is available in any county. applications must be filed which cover at least 50 farms (or one-third of the farms growing insurance crops). Any landlord, owner, tenant, or sharecropper may insure his enterest in a cotton crop up to 75 per cent of the average yield.


