Report of District Engineer Received By Journal-Patriot Wednesday

Four flood control dams, two on the Yadkin above Wilkesboro and two on Reddies River, Yadkin tributary north and west of North Wilkesboro, have been recommended as favorable by engineers of the War Department.

The report received by The Journal-Patriot from Brigadier General James B. Newman, division engineer of the War department, Atlanta, Ga., stated that the estimated cost of the recommended dams was \$7,194,000 with \$25,000 annually for operation and maintenance. The reservoirs would be used only for impounding excess water during floods and would impound up to six inches of flood run-off from the drainage areas above them. The report of the engineers is the result of a survey authorized

by a resolution of the Senate Committee on Commerce March 24, 1946, of which Senator Josiah W. Bailey is chairman.






