

## Four Road Projects In Wilkes Listed For Bids On May 23rd

### Parsonville And Hays Roads Will Get Improvements

#### Many County Road Projects Included In List on Which Bids Are Asked

The State Highway and Public Works commission has four Wilkes county road projects listed for bids to be received May 23.

All the projects are on county roads, which is in line with the present policy of improving farm-to-market roads and school bus routes.

The major project listed among those from Wilkes calls for reconstruction and black top surfacing of 4.80 miles of road from highway 421 at Purllear Grocery ten miles west of this city to Parsonville.

The road from Fairplains toward Traphill will be regraded and surfaced a distance of one and three-quarter miles from near Mulberry Creek toward Hays.

Another important county road will be improved. Bids will be asked for surfacing approximately three miles of road from Ronda to Clingman.

The other project in Wilkes calls for surfacing of three-quarters of a mile of road from Pleasant Hill to Pleasant Hill church.

A total of 68 state highway and county roads projects were week for bids, and the total cost was estimated at \$2,345,000.

### Veterans Foreign Wars Commander Condemns Strikes

#### Dr. McNeill Head of Local Post, Writes Strong Letter to Members

Dr. J. H. McNeill, commander of the Wilkes post of Veterans of Foreign Wars, in a recent letter to the post's membership strongly condemned the strike situation in the United States and called on the members as veterans to fight for better conditions.

Text of the letter of Commander McNeill to the post follows: "I greatly regret that I cannot be present to bring this matter to you personally, but other business prevents.

"I want to bring to your attention, for action, the matters of strikes, (particularly the coal strike) and reconversion. Don't

intention to get this post into any argument on the virtues of Capital and Labor. We can't do that, but all will agree, no matter which side you favor, that something definite and drastic should be done to regain "The American Way of Life."

"When we were drafted or volunteered for service we were told that we were fighting against "Tyranny" and for the right to carry on the "American Way of Life." That implied that we were fighting for our loved ones at home, the right to own our own homes, to work as we pleased, for whom we pleased and where we pleased. It implied a right for enough food to feed them. It implied a right to try to get the luxuries which the average American considers necessities.

"Does the present status give us any of the things we might have expected?"

"No, but why? It's because of strikes!"

"It's because a lot of hoggish people are fighting to run this country. These hoggish people are on both sides of the fence. Most of them are civilians who, being engaged in "Essential Employment," avoided military service, the discomforts and rigors of war, stayed home, lived in relative comfort and did quite well for themselves financially.

"Think these questions over. Are you comfortably housed in a place of your own? If you are not, what chance have you of getting that house—or even of getting the materials to build one? Can you get the materials, tools and equipment needed to set you up in business or to carry on your old business? What are the answers? What are you going to do about it?"

"Are you going to sit back and let these hoggish interests run our country, endanger health—even life itself, and deprive you of normal life necessities?"

"Remember my platform on election to this office was that this is a non-political outfit, run for the benefit of service men. On my induction into office, I told you that Republicans might have to vote Democratic, and vice versa. We must bind together, as service units, for our common benefit.

"It is my earnest desire that you discuss this matter. If you disagree with the above, say so. If you agree with the above, Do Something About It!"

### Sam Segraves Is Victim Accident On Highway 421

#### Achie Segraves, Brother Held on Manslaughter Charge; Other Counts

Samuel William Segraves, 35, resident of North Wilkesboro route three, was instantly killed at 12:30 a. m. Friday when the car in which he was riding struck a bank and overturned on highway 421 seven miles east of this city.

The car, a 1940 Ford tudor, was driven by Archie Segraves, brother of the accident victim.

Patrolman Lamar Ratliff, who investigated the accident, said that Archie Segraves was arrested on charges of manslaughter, driving while intoxicated, speeding, reckless driving and driving without operator's license.

The car was traveling eastward when it left the road, struck the bank, overturned and turned around. It was completely demolished. Archie Segraves escaped without serious injury.

Segraves is survived by his mother, Mrs. Carrie Segraves, and the following brothers and sisters: Coy and Archie Segraves, North Wilkesboro; Norwood and Howard Segraves, Portland, Ore.; Misses Fern and June Segraves and Rex Segraves, at home.

Funeral service for Sam Segraves was held Sunday afternoon at Antioch church.

### 3-County Meeting Held In This City To Discuss Plans

#### Meeting Goes on Record For Early Action On Flood Control Proposal

People of the Yadkin river valley are preponderantly in favor of the flood control plan as recently recommended by War Department Engineers.

This fact was evident following a meeting of citizens of Wilkes, Surry and Caldwell counties called and held here by the Flood Control committee, which is made up of members from Surry, Wilkes and Caldwell counties. John E. Justice, Jr., of North Wilkesboro, is chairman of the committee.

The meeting, called to discuss the flood control plan as recently recommended by the engineers, went on record favoring the plan, which calls for two flood control dams on the Yadkin west of Wilkesboro and two on the Reddies River, Yadkin tributary, near North Wilkesboro.

At the meeting here Thursday Brigadier General James B. Newman, of Atlanta, division engineer of the War Department, explained in some detail the flood control plan as recommended, which calls for erection of the dams to be used only to impound excess run-off during floods, and which would not be used for generation of power.

On the Yadkin the dams would

North Wilkesboro. On the Reddies river the dams would be

1.8 miles and 12.8 miles above North Wilkesboro. According to the advice of engineers, the dams could impound six inches of flood run-off from their drainage area, which is deemed sufficient to protect the valley below from flood disaster, even in the event of a flood equal to that of 1916 or 1940.

The recently recommended plan takes the place of a former plan by the engineers for a combination flood control and power dam on the Yadkin above Wilkesboro, and which was eliminated from the flood control authorizations by the senate at the insistence of Senator Josiah W. Bailey, who objected on the grounds that the lake would flood too great an area of valuable farm lands and that the project was primarily for power with flood control secondary.
