Trenton, N. J.-Legal action was launched yesterday in the Supreme Court to bar daily reading of the Bible in New Jersey schools

The action was filed by Donald D. Doremus of East Rutherford and Mrs. Anna Klein of Hawthorne, filing as taxpayers, against the Hawthorne Board of Education and the State. Mrs. Klein's daughter Gloria, 17, is a pupil in the Hawthorne High School.

Their suit charged that the U. S. Constitution is violated by a State law requiring the reading of at least five verses from the Old Testament "without comment" in public schools at the opening of the day.

### 'Smallest Woman' In World Dies At 74




