Raleigh, June 5 - A patient at the State Hospital for the Insane was docketed for trial on an 18year-old murder charge during the term of Criminal Court scheduled to begin this week.

Hospital officials said the most Alfred Kestler could hope for was a transfer from the ward for the criminally insane. Doctors said there was little or no chance that Kesteler would be released from he hospital.


