

How can these losses be avoided? First, if you are a worker, age sixty-five or over, let us know at once if you are laid off. Second, if you are the widow of a wage earner, inquire as promptly as possible about your rights. Third, a claim must be filed before any payment can be made. Fourth, the Social Security, Act permits back payments for three months period only, so you can readily see that if you delay filing your claim longer than three months you stand to lose one or more month-
