Instead of mourafolly adding up the a-mount of any loss as a ground work for som-plaint, it would be well to subtract it from stat is left, that we may see how much remains as a basis for gratitude. It is very bourd, says Plutarch, to lament for what is lost, and not to rejoice for what it left, a propos to which he quotes a wise speech of Aristipous, the Cyreniac philosopher, who Aristippus, the Cyreniae philosopher, who having loss a considerable farm, said to one who seemed excessively to compassionate

his misfortune, "You have but one field, I have three left; why should I not rather grieve for you!"

Discontent becomes still more unreasona-ble when people bewail the loss of that of which the possession gives them no pleas-ure. Determined to reserve to themselves a right of complaint, they tase up with fate upon the same knavish principle as the schoolboy's "heads I win-tuils you lose." Division, also, is a valuable rule, for we have our sorrows by imparting them to a sympathising friend; while, contradictory as it may sound, we double our own graifications by sharing them with another. In conclusion, let it be recollected by those who stuly the calculations and the arithmetie of happiness, that the merest trifles may be made to minister to its support, even as a swimmer is enabled to keep his head above water by blodders filled with air;--that the bur 'en which is well and cheerfully borne coas s to be felt; that not to wish for a thing is the same as to have it; - that not to regret 'one is still to possess what we like, simply by liking what we have.

#### PLAYING CARDS.

In Goodrich's History of France, we find the following interesting account of the carty history and signification of playing carder. "It is a very singular fact, that no change

has been made in the form of figures on cards, since the time of Charles VI. Those which are now played with, resemble in all respects those which were used to amuse that monarch, and a very just idea of the dress of that period may be obtained from them

The figures had a dist net meaning. the hearts, were meant the churchmen, from the French word cour, meaning heart, and kes pro conferen and heard ex parte as to them. these cards are called "gens de chaur," or choirmen. By the spades, which are in fact pikeheads, are meant the noblest or military, By the square stones, or titles, which we call diamonds but which the French call curreaux. were intended the class of workmen. And lastly, the suit, which we call clubs, but which is in fact a leaf of clover or trefoil, was meant to represent the peasantry,"
