THE RACES.
UNION COURSE, LONG ISLAND.
SECOND DAY.

Wednesday, May 31st.—Purse of \$300 for three years old; 90 lbs; four, 104 lbs; five, 114; six, 121 lbs; and aged 136 lbs.—Mares and G-ings allowed 5 lbs.—Two mile heats. The entries were confined to two promising little sport, viz:

R L Stevens' ch h Tom Moore, by Eclipse, out of Lalla Rookh, by Ogles Oscar—and
 Jos H Van Mater's gr c Manolopon, by Medley, son of Sir Hal, dam by John Richards, 4 years old.

At the appointed hour, both were ready, and when uncovered, showed condition. They moved up evenly at the call, and got off at the first attempt. They ran together head and head around the turn at lively pace. Tom being on the inside. At the commencement of the back stretch Tom showed a few feet in front, and kept the lead about a length round the north sweep. As he neared the stand he widened the grip, and at the mile end was three lengths in advance. He now led off the second mile, keeping thus in front to the centre of the north straight. Here the Grey went up & made a dash, a narrow brush was kept up to the quarter stretch, when Tom being something in hand, let out, and after running with him about 200 yards, shook him off and came home about two lengths ahead, winning the heat easily in 3m 59s.

Second Heat.—
 They went away as before at the signal, and ran neck and neck to the middle of the back stretch, when Tom Moore drew out clear, and kept in front round to the stand, at termination of the first mile, where he was three lengths in advance. At the commencement of the second mile, the grey appeared to flag. Tom now had it all his own way, kept in front, and with something in hand, came home three or four lengths clear, winning the heat in 4m.

 Col Hampton's filly was not here; she and Mr Vail's colt part for the. The other two appeared at the call—Shadow, whose name was on the list. When stripped they all showed good condition except W. D. son's ch whose appearance we by means liked; he was to our mind, too high in flesh and full and appeared somewhat stale upon his legs.

At the call, they came up in brisk motion pretty evenly, but the signal (top of the drum) for this start, not being given, it was "no go" and they were recalled. The majority, however, went at a brisk pace, nearly round the first quarter mile sweep before stopping, and Shadow and colt of Medoc's dam ran to the middle of the back stretch before they could be pulled up.

At the second attempt they all got off very evenly. Shadow having the inside piece, made running from the score for the lead which he got, and dashed off in good style. The Charlotte Temple filly laying close up, the others in a rush, half a length to a length behind. Shadow, however, gave no respite, he kept on at a racing pace was never once headed, and came home with something in hand, two lengths in front.

Second Heat.—All five paraded at the call. At the signal they got away without hindrance; Shadow as in the first heat making the running half a length in front; the Charlotte Temple filly went up with him, the Polly Hopkins colt third, and the other two nearly in a rush. Shadow kept his rate and led the way gallantly. While swinging round the north bend, the Polly Hopkins colt passed the Charlotte Temple, and went up to Shadow; the pace was now good, and Shadow kept his rate. They now were making the last turn, and entering upon the straight run home; here the Polly Hopkins made a dash and made severe running, ran up to Shadow; they went along together gallantly about two hundred yards, when the pace told upon the Polly Hopkins colt. Shadow shook him off, and won by a length, thus winning the heat in 1m 54s, and the stakes of \$100, forfeits included, were good for \$500.


