

When he left me he said he got in with a North Carolina waggonet by the name of Wm Browney, of Caswell county, who the boy said first conducted him off, and promised to take him where he was raised; and I suppose when he made his last escape he was making for that county. This boy is about 15 or 16 years of age, of a dark mulatto color, he is four feet 8 or 10 inches high, he is left banded and has a scar of a burn on his left wrist, and his left big toe is cut off above the nail. This boy when he was in Salisbory Jail, called his name George, and said he belonged to James Patterson, of South Carolina, which was the man I purchased him from. 


