We perceive from the Val. ley Whig that a meeting of the iron-masters of Western Virginia has been called, " to take into consideration the present condition of the iron business, and to respond to the recent more of the Pennsylvania iron men," That paper expresses the belief that unless something is done at the next Congress to check the importation of foreign iron, and to relieve our manufacturers, there will not be a furnace in blast among us in 12 months. We observe, likewise, in the Railroad Journal, of September lit, that at least one bundred thousand tons of Railroad iron have either been received or ordered in this country in the last twelve months. at a cost of not less than \$5,000,000. That this influx of foreign iron will continue, and that it will result in the entire overthrow of our own manufactories, is beyond all doubt.

THE CASE OF THE DISMISSAL OF MR. JACKSON, THE BRITISH MINISTER .- The Washington Correspondent of the Philadelphia North American, publishes the following particulars of this case :

In the case of Jackson, the British Minister, who was dismissed under Mr. Madison's administration in 1809, our Government'did not submit his correspondence to the British Government, but dismissed him on receiving an offensive note, without furnishing an opportunity for the amende honorable. The course of President Taylor has been more lenient, forbearing and generous. The offence in Jackson's case was this: Erskine, who preceded him, had made an arrangement relative to the then existing difficulties between the two Governments. embracing among other things, the repeal of the British Orders in Council. The British Government undertook to disavow this arrangement, and Mr. Jackson informed Mr. Smith (then the Secretary of State) that it was void, because Erskine had no instructions from his government to make it, and that the American Government must have been aware of that fact, because it had been announced to Mr. Pinckney, our Minister in London. Secretary Smith answered that the Government had every reason to suppose Erskine was fully empowered, and had no knowledge of his want of instructions. Jackson reiterated his assertion. Smith replied that his language had become offensive, and was inadmissible, because he had before written to the British Government, disavowing the knowledge which he again charged. Jackson rejoined, professing great respective the Government, and an anxious desire to maintain friendly relations, but claiming freedom of discussion as a Minister, and again re-stating the argument from which he inferred that his Government must have had knowledge that Mr. Erskine was not instructed or empowered.-By Mr. Madison's orders, the Secretary immediately wrote to Mr. Jackson, saying that the Government would hold no farther correspondence with him, and put an end to the mission. The British Government, so far from taking offence at the course pursued forthwith issued an official recall, expressing its regret that this Government had adopted the formal diplomatic course of laying the complaint before them, to be redressed by the Government; and Mr. Foster was promptly sent to succeed Mr. Jackson, under the administration of Lord Wellesly.




