

Thinness of a Soap Bubble .- A soap bubble, as it floats in the light of the sun, reflects to the eye an endless variety of the most gorgeous tints of colors. Newton showed that to each of these tints corresponds of a certain thickness of the substance forming the bubble; in fact, he showed in general, that all transparent substances, when reduced to a certain degree of tenuity, would reflect these colors. Near the highest point of the bubble, just before it bursts, is always observed a spot which reflects no color, and appears black. Newton showed that the thickness of the bubbles at this black point was the 25.-000,000th part of an inch! Now, as the bubble at this point possesses the properties of water as essentially as does the Atlantic Ocean, it follows that the ulti-






