A PROCLAMATION.

By James W. Ellis, Governor of North Carolina.

AN ACT CONCERNING A CONVENTION OF THE PEOPLE.

Whereas, The present perilous condition of the country demands, in the judgment of this General Assembly, that the sovereign people of this State should assemble in convention to effect an adjustment of the Federal Union...

Section 1. Be it therefore enacted by the General Assembly of the State of North Carolina, that it is hereby enacted by the authority of the same...

Section 2. Be it further enacted, That it shall be the duty of the sheriffs to make out duplicate statements of their polls in their respective counties...

Section 3. Be it further enacted, That it shall be the duty of the Governor, as soon as he shall receive the returns of the sheriffs...

Section 4. Be it further enacted, That the election for delegates as aforesaid shall be held and conducted in the same manner as elections for members of the General Assembly...

Section 5. Be it further enacted, That if a vacancy shall occur by the death, resignation or removal from the State...

Section 6. Be it further enacted, That the said convention shall consist of one hundred and twenty delegates...

Section 7. Be it further enacted, That the delegates to said convention shall be the same as that of members of the General Assembly...

Section 8. Be it further enacted, That the said convention shall have the power to elect its officers and prescribe its qualifications...
