May 18th Dear Mr. Vining,

I fear I have neglected you of late, but I have, I hope, an adequate excuse inasmuch as I have been whirling about with two of your countrywomen, Mrs. Franklyn Parker and Mrs John Heffron, both of Greenwich, Conn. Mrs Greenfell and I compliment ourselves in retaining just a sufficient spark of life in our guests, could return they the States under their own steam, and not in coffins. It must be ad-nitted that their behaviour here was suicidal. I did not know it was possible for two women to do so many things in two weeks! You will be pleased to hear that they upheld the high standard of American womanhood by being highly entertaining, intelligent. and charming at all times, and never, never, by any chance, sitting still for more than five minutes. They have, alas, departed, and we feel at a loss to know what to do without them. They have, however, so increased the tempo of living that both Mrs Grenfell and I run everywhere now instead of walking!

The weather the past fortnight has been perfect. Not a drop of rain has fallen from the sky. The tulips in the London Parks are a sight for sore eyes; the grass is like green velvet to the feet; the air is soft and warm upon the cheeks.

Judge Pless Appears Before The State Highway Com'n.

Judge J. Will Pless of Marion atended a meeting of the State Highway and Public Works Commission in Raleigh last Thursday and outlined his ideas on classification and segregatoin of prisoners by color, ages, offenses and other causes. Chairman Waynick said Judge Pless was told the commission was working toward classification of long-term prisoners now and expects shortly to announce designation of camps under the system so judges may aid in the work when they impose sentence in court.

This movement was started in Tryon by Judge Pless the past winter and was endorsed by the Kiwanis and Rotary clubs who took initiative in spreading the movement throughout the state, with the view of saving many youths the fate of hardened criminals and of redeeming them for good citizenship.
