## Body of Saluda Man Is Found In Henderson

Hendersonville, March 4.—The body of J. B. Melton, 50, of Saluda, was found at 7 o'clock Thursday evening beside his car on a side road near the High Bridge on the Saluda-Hendersonville highway. The bridge is about six miles from Hendersonville.

The body was found by Lloyd Lindsey, a deputy game warden, who made a report to the Henderson county sheriff's department. Coroner Bruce Cox, of Henderson county, and sheriff's deputies are making an investigation. Mr. Cox said an inquest will be held on Wednesday afternoon at 2 o'clock.

The coroner said no marks were found on Mr. Melton's body and he was of the opinion death was due to a throat or lung hemorrhage.—Asheville Citizen.
