

Law offices located a 1101/2 Kennedy place have been opened by Judge Joseph J. Gentry, formerly of Landrum, one of the oldest members of the Spartanburg bar, according to an announcement yesterday.

Judge Gentry is well known in Spartanburg county where he has practiced law at intervals for 40 years. He was probate judge of Spartanburg county for 16 years. He was also a magistrate for two years and once was county master.

For sometime, he attended the theological seminary and is a Baptist minister. During the World War, Judge Gentry was in Y. M. C. A. work as a chaplain. His father was sheriff of Spartanburg county for a number of years.

For several years, Mr. Gentry has been one of the up-county peach growers. He owns the Bird Mountain Peach Orchards and operates other businesses at Bird Mountain.

The purpose of this board is to work with the County Agents in establishing an Extension Program for their respective townships.
