Miss Margaret F. Ford of Charles, S. C., died in Tryon this morning in her 102nd year. The body will be taken to Charleston, S. C., on Saturday and funeral services will be held at Connally's Chapel, Charleston, on Sunday, March 13. Miss Ford had made her home in Tryon for sometime and passed her 101st birthday here on December 5th. She was born in 1836 near Georgetown, S. C., and was a member of a prominent South Carolina family, the daughter of Stephen and Jane Thurston Ford.
