## Rev. John A. Pinckney Resigns to Accept Charleston Call

Rev. John A. Pinckney, rector of the Church of the Holy Cross for the past year and a half has resigned to accept a call to St. Paul's Episcopal church in Charleston, S. C. The change will be made on September 1st. St. Paul's was consecrated in 1816 a few years after it was built and has a much larger congregation than Holy Cross. Although regretting to give him up Tryon friends are glad of his call to a larger field. Mr. Pinckney came to Tryon in November 1936 and has taken part in Boy Scout work and public school athletics. For the past two years he has been the director of the Episcopal young People's Conference at Kanuga Lake, and will direct their activities again this summer.
