MONTGOMERY CASE IS NON - SUITED

Hendersonville, Oct. 14.—Judge J. Will Pless, Jr., of Marion, nonsuited manslaughter charges against Walter S. Montgomery, prominent Spartanburg, S. C., textile manufacturer, in Henderson county superior court Friday afternoon.

The action came after the defense had rested its case and had renewed its motion for a non-suit judgment.

The jurist said that the "ends of justice require that the motion be allowed" and expressed the belief that a conviction could not be obtained if the case went to the jury. He said he could not conscientiously allow a conviction to stand even if one were obtained. District Solicitor C. O. Ridings of Forest City, was in accord with the ruling, Judge Pless said.
