## Body of Missing Negro Found By Searchers

The body of Reuben Mills, Tryon Negro, missing since last Friday when he left for a squirrel hunt, was found early Tuesday afternoon by CCC workers in the woods near Sandy Gap on the Hogback road. A coroner's inquest held at the McFarland Funeral Home by Coroner O. C. Bridges, directly after the finding of the body found that the deceased Negro died from natural causes. Members of the coroner's jury were as follows: G. H. Bridgeman, C. A. Durham, J. W. Taylor, E. B. Arledge, C. S. Ford and D. B. Lindsay. According to Sheriff W. D. Hines the \$50 reward will be paid to Lieut. J. F. Buckman, Commanding Officer of Company 441, CCC, Greer, South Carolina.

Funeral services will be held this afternoon at the Garrison Chapel Baptist church with Pastor Cherry, officiating.

Reuben had been having good luck on his hunting trip; three squirrels were found in his hunting bag and one was lying on the ground beside him. Evidently he had just killed the last squirrel when he was taken with a heart attack.
