Polk County Jury Finds Shelnutt Guilty

Appeal Expected to Be Taken By Defendant.

Harold Lee Shelnutt, former accountant and bookkeeper for the firm of Jackson & Jackson, Inc., Tryon firm, was found guilty late Friday afternoon on the charge of forgery by a jury that deliberated a little more than two hours after hearing evidence for three days.

Shelnutt was charged with forging the name of the senior member of the firm, J. N. Jackson, on checks against the firm's bank accounts in Tennessee and in New York City banks.

Superior court, presided over by Judge Wilson Warlick of Catawba county, was recessed until Monday when the attorneys for the defense indicated that an appeal would be taken. Shelnutt was released on a bond of \$5,000.

Shelnutt, former owner of Sunnydale, local recreation center, and of a large hotel in Saluda, N. C., was represented by the law firms of Massenburg, McCown & Arledge of Tryon and Hamrick & Hamrick of Rutherfordton. Solicitor Clarence O. Ridings was assisted in the prosecution by Attorney J. E. Shipman of Hendersonville.
