John M. "Jack" Camp has returned from Athen, Tenn., where he attended the funeral services of his uncle, Judge Clem Jones, prominent lawyer of that city. Judge Jones died on Saturday. The Chattanooga Times and the County Bar Association were high in their praise of the Judge who had been prominent in political affairs of that section of the state. He was 65 years old, a veteran of the Spanish-American war, attorney for the L&N Railroad and the Tennessee Power Co. He was reared in Tryon and was a son of the late Rev. Milner Jones, former rector of the Episcopal church here.
