C., and points in Spartanburg County, S. C.; from points in Spartanburg County to Charlotte, N. C.; from Charleston, S. C., to points in Rutherford and Polk Counties, N. C.; from Spartanburg, S. C., to points in Rutherfordton and Polk Counties, N. C., and from Henderson, N. C., to points in Spartanburg County.
