## WOMAN ENDS HER LIFE WITH SHOTGUN CHARGE

Funeral rites for Mrs. Ira Pritchard, 23, of the Pea Ridge section of this county were held at 2:30 Sunday afternoon. Interment was in the Byars family cemetery nearby.

Mrs. Pritchard, according to officers, used a single barrel shotgun to end her life in the front yard of their home late Saturday afternoon in the presence of several relatives. The charge from the gun entered just below the heart and caused almost instant death. No cause for the act was known.

At the inquest held at Columbus later in the afternoon, the coroner's jury returned a verdict of "death by self-inflicted wounds."

An adopted daughter of Mr. and Mrs. Boney Connor of Mill Spring she is also survived by her husband and several foster brothers and sisters.
