She wants more information about Tryon's weather and is planning to come here The State Department of Conservation and Development at Raleigh sends a copy of all its inquiries to the Chambers of Commerce all over the state, and the Chambers of Commerce follow up the inquiries with local information. Miss Rion goes over this list and selects the names of people thought to be interested in this community and sends them literature of Tryon and hotels and inns, also a copy of the Tryon Daily Bulletin. Each applicant to the State for information is therefore flooded with literature from communities all over the state. Polk Superior Court Has Busy Session

The trial of L. R. Wells, Arthur Suber, Hattie Smith, of Tryon and Cleveland Rice of Spartanburg, all colored, charged with the burning of the Tryon colored school building on the morning of June 6th, was begun Wednesday. The trial is expected to last through Thursday.

Rice, Smith and Suber have remained in the county jail since their arrest several days after the fire, and Wells, principal of the burned structure has been free under bond of \$5,000. This bond was required of each of the four defendants, with only Wells posting it.

Prior to this case, the court, with Judge Bobbitt of Charlotte presiding, has disposed of the following indictments:

James Scruggs, larceny, four months; Charlie Cady, violation prohibition law, six months or \$50 and costs; Hicks Hodge, driving drunk, 60 days or \$50 and costs; Roy Peace, driving drunk, 60 days or \$50 fine and costs; Wilburn Blackwell, driving drunk, 60 days or \$50 and costs; Henry Flynn, driving drunk, 60 days or \$50 and costs; Charlie Van Patton, driving drunk, 60 days or \$50 and costs; Frank H. Green, driving drunk, 60 days or \$50 fine and costs; C. J. Price, driving drunk, 60 days or \$50 and costs; Howard Ruff, driving drunk. (second offense), three months on road; Zack Sain, violation of prohibition law, six months on road; Floyd Bruce, driving drunk, 60 days or \$50 and costs; Johns Pack, assault with intent to kill, two years
