## Child Dies In Fire At Landrum, Tuesday

A nine-year-old boy was burned to death and seven other members of his family were burned badly enough to require hospital treatment about 9 o'clock last night. The flames left their three-room farmhouse near the Joseph Walker school, four miles east of Landrum, in a smouldering mass of ruins.

The fatally-burned child was Marion Abernathy, Jr., son of Mr. and Mrs. Marion Abernathy, who live on the Campobello-New Prospect highway near the Joseph

Walker school.

The child's parents and six brothers were brought to the General hospital here, where at least one of them was believed in a "dying" condition early this morn-

The injured: Marion Abernathy, 45; his wife, Mrs. Mollie Roddy Abernathy, 49; five sons, Oscar Abernathy, 25; Robert Abernathy, 21; Jessie Abernathy, 13; Roy Abernathy, 11; and Baylis Abernathy, 4.

All of the injured suffered burns of varying degrees-Jessie the most serious. In addition, Robert suffered a badly-lacerated arm from broken window glass.

Three members of the family escaped serious injury in the fire which leveled their frame dwelling home and which investigating officers reported apparently was started by an explosion of gasoline or kerosene in the kitchen of the house
