C. J. Lynch Named Polk Co. Civil Defense Chairman

Theodore S. Johnson of Raleigh, director of Civil Defense for North Carolina, has notified C. J. Lynch of Tryon that Governor Broughton has appointed him to be chairman of the Polk County Council for Civil Defense. This council will cooperate locally with the government in all its phases of promoting national defense and will include the collection of aluminum, promote fire drills or anything necessary. Chairman Lynch states that he is asking the mayors of Columbus, Saluda and Tryon to be the chairman in their respective communities for the collection of aluminum, and County Commissioner Grover Feagan to represent the rest of the county. A county committee of about ten citizens will be named within a few days for other activities. The aluminum will be collected during next week. The aluminum collected will be put in the Tryon depository on Trade street.
