TIRE RATIONING REPORT

Report of the Polk County Tire Rationing Board at the end of the month of January 31, 1942:

Tires and tubes issued at meeting of board, January 30, 1942—

J. Robert Foster, Mill Spring, 2 passenger car tubes; Howard Ruff, Mill Spring, 2 truck tires and 2 tubes; J. M. McGuinn, Mill Spring, 1 truck tire; R. L. Farthing, Tryon, 2 tires and 2 tubes, (obsolete); W. J. Screven, Tryon, 4 tubes (obsolete); G. A. Gilbert, Columbus, 1 truck tire and 1 tube; R. H. Prince, Route 1, Chesnee, S. C., 2 truck tires and 2 tubes; Gaither Johnson, Saluda, 1 passenger car tire and tube; B. A. Whitesides, Mill Spring, 1 truck tire; Myrtle Mae Pearl, Tryon, 1 passenger car tire; S. B. Edwards, Sr., Tryon, 2 tires and 2 tubes (obsolete).

The following is a monthly report which the Tire Rationing Board of Polk County sent to the chairman of the Polk County Civil Defense Council and to the State Tire Rationing Administrator Theodore S. Johnson:

1. The quota received for Polk County for the month of January is as follows—truck tires, 21, tubes 18; passenger car tires, 7, tubes 6.

2. Number of applications, 26.

3. Number of application disapproved: (a) outside classification, 3; (b) over quota, none.

4. Number of certificates issued during month, 39.

5. Number of tires and tubes authorized to be purchased: Truck tires 16, tubes 12; passenger tires, 7, tubes 7; obsolete tires, 9, tubes 12.

6. Number of foreign certificates issued, none.

Funeral services will be held at 2 o'clock Wednesday afternoon at the First Baptist church in Columbus. Interment will be in the Presbyterian cemetery in Columbus. The Rev. D. M. McGeachy, will officiate, assisted by the Rev. Dr. G. V. Tilley.
