The sheriff's run-off race will be held Saturday of this week between W. D. Hines, and W. Y. Wilkins . . . . Pinckney Williams is now a staff sergeant in the U. S. Army and is stationed somewhere in Peru, South America. His mother, Mrs. E. Pue-Williams, sends him several weeks' supply of Bulletins by airmail . . . Grover Furr, Jr., son of G. C. Furr, Sr., formerly superintendent of the Sams-Millis here, was a recent visitor to his parents at High Point. Grover, an airplane pilot has had thrilling experiences piloting airplanes from Miami, Fla. 14,000 miles across the ocean, desert and mountains to Africa, China, Burma and India. His ships carry food, medicine and ammunition and sometimes refugees. His 21 passenger plane brought 59 refugees out of Burma away from the Japanese. He says the American Volunteer Group, "Flying Tigers" is the greatest fighting aggregation in the war. He says if there were enough of them they would make a real dent in Japan. For the past

## Governor's Proclamation

**Fifth Registration Day, Tuesday, June 30, 1942, 7 a. m., to 9 p. m.**

Whereas, the Selective Training and Service Act of 1940, as amended, authorizes the President of the United States to designate the times and places for the registration of the persons required to register by the provisions of said Act; and

Whereas, the President of the United States duly designated October 16, 1940, as the First Registration day; July 1, 1941, as the Second Registration day; February 16, 1942, as the Third Registration day; April 27, 1942, as the Fourth Registration day; and has now, by proclamation dated May 2, 1942, designated

**TUESDAY, JUNE 30, 1942**  
between the hours of 7:00 a. m. and 9:00 p. m. as the Fifth Registration Day; and

Whereas, the President in said proclamation has called upon me, as the Governor of the State of North Carolina, to do and perform all acts and services necessary to accomplish and effect the complete registration in this State of all those required to register according to said proclamation:

Now, Therefore, I, J. Melville Broughton, Governor of the State of North Carolina, in response to the call made upon me as contained in the proclamation of the President of the United States referred to above, and by virtue of the power vested in me as Governor of this State, do proclaim the following:
