The Program For Scrap Collection

1. The Tryon junk yard opposite Chevrolet garage, under charge of F. P. Bacon, will be continued in use for metal and rubber scrap that is donated.

Materials conveniently placed by the roadside in the vicinity of Tryon will be collected by the Town of Tryon trucks. Notify the Town Office. Collections along the main highways will be made by the State Highway trucks, Notify Supt. Clayton Constance, at Lynn. Proceeds of sale go to county defense agencies. No deductions for personal expenses.

2. Each public school will collect and sell scrap; the proceeds to be used by the school for its own purposes. Persons with trucks and wagons can perform a valuable service by assisting in transportation.

3. Persons having heavy materials, mill machinery, etc., to be scrapped will notify Mr. Bacon, who will send dealers to arrange for payment and removal.
