PACK IS BOUND OVER IN "THREAT" CASE

Floyd Pack, 35-year-old Polk county sawmill man, was bound over to the May term of U. S. district court under a \$10,000.00 bond by U. S. Commissioner Eugene Taylor Thursday on charges of making threats against **Presi**dent Roosevelt.

The defense entered a plea of not -guilty but offered no testimony at the preliminary hearing.

mony at the preliminary hearing. Joseph E. Taylor of Lynn testified he heard Pack declare one day at the sawmill where he was working: "I'd give \$1,000 to blow the whole damned works plumb into hell." He said the defendant was referring to President Roosevelt and congress.

He also quoted Pack as allegedly having said he'd "rather be under Hitler as under that damned crowd."

William F. Pack, of near Tryon, the other witness, testified he had heard the man make similar statements.—Asheville Times.
