Warning Issued To Selective Service Registrants

"A fine of \$10,000 or five years in prison, or both, is the penalty facing a person convicted of delinquency under Selective Service Act," General J. Van B. Metts, State Director of Selective Service announced today.

To further clarify the requirements, General Metts emphasized the following:

"Every person who was required to register under any one of the six Presidential Proclamations which have heretofore been issued, except those registrants in the 45-65 year old group, must have in his personal possession at all times a valid Notice of Classification in addition to his Registration Certificate."
