## COURT ADJOURNED

Polk County Superior Court adjourned Thursday afternoon after one of the shortest sessions in the history of the county. The criminal and civil dockets were cleared in four days. Criminal court lasted three days and Thursday was taken up with several civil cases.

Criminal cases not given in previous reports was one against Albert Sawyer, who pled guilty to abandonment and non-support. He was ordered to pay costs, and \$15 by February 15th and \$10 on the 15th of each following month. Failure to do so would put into effect a sentence of six months in jail and work on the roads. Willie Glenn pled guilty to willful trespass and was ordered to pay costs and prayer for judgment continued.

Papers were issued for W. Arthur Ormand, charged with abandonment and non-support; and for Daniel F. Boone, who was indicted by the Grand Jury for embezzlement of his daughter's funds left in trust by the child's grandfather, the late Clarence A. Lightner.

On the civil docket judgment was rendered for the bondholders against the Town of Columbus.

Divorces were granted in the cases of Abbott vs. Abbott and Moffitt vs. Moffitt.

In the Arra Lankford case, T. H. Lankford sought to keep intact all the real estate of his late sister, who had willed him the income from her interest in a store building in Saluda, during his life time. After that time all the property will go to the Saluda
