FEDERAL COURT NEWS

The Asheville Citizen reports that liquor cases predominated actions heard in the U. S. District Court Wednesday and that among the cases disposed of was that of Russell Lockhart, Louis Lockhart and Rubben Lockhart, all of Polk County, who answered to charges of manufacturing non-tax paid liquor. Each was given the alternative of serving 18 months in prison or paying \$750 fine and going free under three years probation.

William M. Spivey pleaded nolo contendere to charges of embezzlement and making false entries and was sentenced to 18 months in prison. However, he was given until January 2, to arrange his affairs and was released on \$2,500 bond for his appearance to begin serving sentence at that time.
