The Landrum girl, student at Tryon High School, was located in Louisville, Ky., Sheriff Brockman reported Thursday. He said the girl's father left Thursday to bring her home.

Sheriff Brockman pointed out that no charge is pending against the girl and that for this reason it was decided her father would be

the proper person to bring her back home. Officers said they had not yet determined how the girl made her way to the Kentucky city after being sought here and in various sections of North Carolina as a witness in the case in which several men reportedly accompanied her across the State line in an automobile.

Watson told Spartanburg Mrs. and Polk County officers that she last saw her daughter standing on the highway near their home. She said a car stopped where she was standing and that when it pulled away the girl was gone. She said she could state positively not whether the girl got into the automobile.—Spartanburg Herald.
