TAX MONEY

Howard Greene had charge of the Kiwanis program Tuesday at Oak Hall.

Floyd Evans of the Polk County Welfare Department spoke on the organization of the Welfare Department. Mr. Evans stated that there are 29 different functions of the department and that only 6 involved the spending of money.

The speaker stated that the welfare board must pass on every grant and must approve the raising of a grant. The board consists of three men; one is appointed by the State Welfare Department, one is appointed by the County Commissioners, and these two men then elect the third member. The board hires the superintendent, who in turn hires the other employees.

The welfare employees are under the North Carolina Merit System and can only be fired for three reasons: engaging in political activity, being convicted of moral interpretude and inefficiency. However, no employee can be hired unless he meets the merit system's requirements.

Mr. Evans said that the money paid out by the welfare department for Old Age Assistance, Aid to Dependent Children, etc., come from the Federal, State and County governments. The speaker also pointed out that the Welfare Department cannot tell a recipient of a grant how he must spend the money.
