Rev. and Mrs. Paul F. Davis left Monday for their new home at Dallas, Oregon, where Mr. Davis will teach English and Social Studies in the high school.

Mr. Davis surprised his congregation with the announcement Sunday morning at the Tryon Methodist Church which he has served since the last Conference in October.

Mr. Davis in addition to his divinity degree from Emory University also holds a degree in education from the Missouri State Teachers College at Springfield, Mo. In order for him to accept his new position in Oregon in time to be ready for the new school year, it was necessary to leave Tryon immediately.
