## One for Mayor and Eight For Commissioner In Town of Tryon Race

Town Clerk C. O. Smith stated Tuesday morning that C. D. Stevens, incumbent, was the only candidate filed for mayor in the coming municipal race on May 5th. Names filed for commissioner included incumbents, E. L. Tollison and Ernest Kerhulas. R. B. Scruggs did not seek reelection and the following names were filed either in person or by friends: Dr. George Farrand Taylor, Harrison Bridgeman Jr., Bob Adams, George D. Cooksey, Eugene Jones, Charles Lankford.

Dr. Taylor has asked that his name be withdrawn; that he appreciates the confidence of the friends who nominated him; and would be glad to serve all the community in any way possible, but since so many fine candidates have filed for the office he does not think it necessary for him to be a candidate.

The remaining candidates are all business people and it will be up to the voters to decide which three of the seven they want to represent them in managing the town's affairs.
