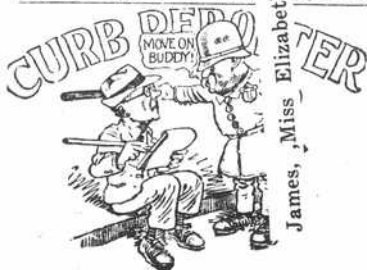

Wilkins Jr., will be open to the public on Sunday, according to an ad in today's Bulletin. It is located near the Burtenshaw house. . . . The coroner's jury gave a verdict Thursday in Columbus that Edwin Ball came to his death by person or persons unknown to the jury. Consequently Solicitor Clarence O. Ridings asked withdrawal of the first degree murder charge upon which Mr. Rhodes was arrested on warrant signed by a brother-in-law of the deceased. On the charge of assault on his wife, Mrs. Stella Rhodes, on warrant signed by their daughter, Mrs. Roy Dalton, the defendant was released on \$500 bond for appearance at a magistrate court later. Time and place not set. Defendant was represented by Attorneys J. Lee Lavender, W. A. McFarland, former Congressman Monroe Redden of Hendersonville.
