MOVE ON FOOT TO OUST SHERIFF LOYD PANTHER

Following several arrests on charges of intoxication Sheriff Loyd B. Panther now faces a movement to oust him from office.

A group of Polk County citizens have signed a petition asking for his removal and Solicitor C. O. Ridings has signed an order calling for a hearing before Judge Will Pless of Marion.

The citizens signing the petition are W. H. McDonald, chairman of the Democratic Executive Committee; R. E. Brantley, representative in the state Legislature; J. C. Williams and Troy Durham, Polk County Commissioners; Tryon Mayor C. D. Stevens; Dr. John Z. Preston, Charles Lankford, R. O. Andrews, Shannon Meriwether and Fred Smith.

JESSE L. RHODES BOUND OVER TO GRAND JURY

A preliminary hearing was held Friday afternoon before Magistrate T. A. Gilliam at the Court House in Columbus for Jesse L. Rhodes charged with assault with a deadly weapon on his wife, Mrs. Stella Streadwick Rhodes. After hearing the evidence presented the magistrate bound the defendant over to the grand jury for action in August.

At the hearing Mrs. Rhodes stated that she had been out riding with Edward Ball and he brought her home about 2 a. m., and when she started to get out of the car her husband appeared at the back of the car with a flashlight in one hand and something else in the other hand. Ball pushed her down on the seat and started the car. About the same time several shots
