LANDRUM MAN HURT AS TRUCKS CRASH

A Landrum Route 2 man was injured this morning when two trucks collided head-on on a onelane bridge near Landrum.

Alvin Norris Fowler, 28, was admitted to St. Luke's Hospital in Tryon, State Highway Patrolman Harry B. Ray said Mr. Fowler received back and leg injuries and face cuts. He was reported "resting fairly comfortably" Thursday night.

The patrolman said Mr. Fowler was driving a 1949 Chevrolet panel truck that was in collision with a 1951 International truck. The two vehicles crashed head-on on Earl's Bridge on the Rutherfordton Road about three miles east of Landrum.

Patrolman Ray said Izell Green. 33, of West Palm Beach, Fla., was driver of the other truck involved. He was not injured. This truck belongs to J. C. Powell of Hendersonville.

The truck Mr. Fowler was driving is owned by Butler's Dairy of Tryon. Damage to this vehicle was about \$300 and that to the other was estimated at \$50, the patrolman said. The wreck occurred about 7:15 a. m.-Spartanburg Herald.

PANTHER ASKS NEW RULING IN DRIVING CASE

Hendersonville, Aug. 6 .- Sheriff Loyd Panther of Polk County. whose automobile driver's license was suspended for a year by the Department of Motor Vehicles, has asked that the suspension be revoked. Monroe M. Redden, his attorney, said here today.

Panther was arrested at Landrum, S. C., on May 3 by Police Chief Joe Hightower and charged with driving while drunk. Accordcording to reports from Landrunt, he failed to appear for trial later.

Panther's request for revocation of the suspension was made at a hearing before Hearing Officer Ralph Stephens of the Depart-ment of Motor Vehicles.

Redden said the revocation was asked on the grounds that Panther had not been informed of a hearing, that he had not signed or posted bail, that no warrant had been served and that the defendant had not been told to report to Landrum for a hearing.
