Tax Forms "Hotline" Available to **Tar Heels**

Greensboro - These days few things are free, but the Internal Revenue Service is offering a free telephone line to North Carolina taxpayers who need additional forms and publications to help file Federal tax returns.

It's as simple as dialing your area access code (1, for example), then 800-241-3860. This is a direct line to the Forms Distribution Center, not for answers to tax questions. Not only are the additional forms and publications fee, but are mailed postage-free.

If a telephone isn't available, use the order blank in the tax forms package received in the mail and send it to the Forms Distribution Center. Either way, the order will be given prompt attention.
