Richard Rodgers, who did the music for a number of Broadway musicals: "South Pacific", "Oklahoma", and "The Sound of Music" along with others died Sunday at his home in New York at the age of 77. He is dead, but his music will live on and on.

Dr. Benhamin Earl Washburn, of Rutherfordton who died last Friday at the age of 94, spent his life promoting better health. He did this locally, nationally and world wide. He was made an honorary member of the Royal Society of Health in London, England. He served for 13 years as health editor of the Progressive Farmer and wrote histories of the Rockefeller Foundation's hookworm campaign, the N. C. Board of Health, and Rutherford County and its Hospital. During World War II he served as director of the Polk-Rutherford Health Dept. and helped organize health departments in most counties in the state. Although he received many honors, Dr. Washburn remained a man of the people and gave his life to promoting better health.
