## Man Shot

Perry Hall of Columbus was shot Friday night about 10 p.m. in front of Bill Plumley's place on Hwy. 176 in Greenville County between Tryon and Landrum. Lt. Earl Barnett, Information Officer of the Greenville County Sheriff's Department said that Hall was shot in the abdomen with a .45 front loading black powder derringer. He was taken to St. Luke's Hospital where on Monday morning he was in intensive care. His condition was reported as serious but not critical.

Lt. Barnett said that Hall was reportedly shot by Charles Maynard of Hendersonville in an argument over cocaine. Maynard had been arrested and was in the Henderson County jail Monday morning. Greenville County officers were scheduled to question him later Monday.
