TAX TIP (Deductible Taxes)

Question: I neglected to pay real estate taxes on my home for two years. This year, realizing my house could be sold for back taxes, I paid all the taxes due.

Can I claim the total three-year amount of taxes paid as an itemized deduction on my 1979 return?

Answer: Yes. For a cash basis taxpayer, taxes are deductible only in the year in which they are paid, regardless of when they were due. If the amount of real estate taxes for the three years—plus your other itemized deductions — exceeds your zero bracket amount, it will be to your benefit to itemize. — Provided as a Public Service of H&R Block, The Income Tax People.
