Half of all Americans consider misuse of soil and water resources a serious problem.

A matter that appears in many divorce disputes is the question of alimony.

In North Carolina, alimony can be applied for by the spouse that is financially dependent on the other spouse. However, to obtain alimony the dependent spouse has to show that the break-up of the marriage was the fault of the other spouse.

It is possible for a dependent spouse to be awarded temporary alimony during the period of separation preceeding the

divorce action.

Parents are required to assume the financial responsibility for rearing their children. If the husband and wife are not able to agree on child support, the judge will make the decision based on evidence submitted to the court.

Alimony and child support can be negotiated and agreed upon even before filing the divorce action, or a separate lawsuit can be brought to settle these issues.
