MARRIAGE LICENSES

Next to the driver's license, probably the most common license in North Carolina is the marriage license.

You must obtain a license before you may be legally married, whether the ceremony is to be civil or religious. A marriage license is obtained from the Register of Deeds of the county where the marriage is to take place.

No waiting period is required before the ceremony. The license is good for 60 days after it is issued.

When you apply for a

license, you must file a certificate of a medical doctor showing that you are free of certain diseases.

The doctor's examination has to be conducted within 30 days before you apply for the license.

After the marriage takes place the Register of Deeds will be notified by the person conducting the ceremony, and a record of the marriage will be made in that office.

There is a free pamphlet on this subject at your public library, provided by The Lawyers of North Carolina.
