### FRESH VEGETABLE VINAIGRETTE (Makes 4 servings)

- 2 medium tomatoes, sliced
- 1 1/2 lb. mushrooms, sliced
- 1 cup broccoli florets
- 1 cup cauliflower florets
- 1/2 cup celery, diced
- 2 green onions, diced
- 1 cup Hollywood safflower oil
- 1/4 cup wine vinegar
- 2 teaspoons oregano
- 1 teaspoon sugar
- 1 teaspoon salt
- 1 teaspoon dried parsley flakes
- 1/2 teaspoon pepper
- 1/2 teaspoon dry mustard
- 1/2 teaspoon dry garlic or 2 cloves fresh garlic, crushed

Cut all vegetables and place in glass casserole dish. Combine remaining ingredients and pour over vegetables. Cover and chill 2 to 3 hours, basting occasionally. Before serving, top with diced green onions

SERVING ON A JURY

Trial by jury is not a perfect system of obtaining justice. But it is generally considered the best system that has been devised.

Serving on a jury has been described as an obligation, a right and a privilege. And those who have served often find it to be educational and interesting as well. Except for an occasional complicated or sensational case, jury duty usually lasts for only a week. So jury duty is hardly something to dread.

But there are times

when a person needs to be excused. An excuse can only be obtained with the permission of the court. Each request is decided on its own merits. Because of special circumstances, sometimes a person's jury service will be deferred until a later date.
