## Commissioners Agree To Remove Hendra From Hospital Board

The Polk County Commissioners during the 5 May, 1980, meeting made the following appointments to the Juvenile Justice Delinquency Program Task Force: for 1-year terms, Donna Anthony, Douglas Roach, Ruth Ross, Carrie Massey, and Roy Morgan; for 2-year terms, Zoro Guice, Julia Wheeler, Marvin Wagner and Pat Lehner; for 3-year terms, Myrna-Viehman, Don Viehman and Betty Brewer.

St. Luke's Hospital Board of Directors requested the Commissioners to remove Larry Hendra from the Board due to a conflict of interest. Chairman Sauve moved "that due to a conflict of interest brought about by the initiation of a lawsuit against the hospital, the Polk County Board of Commissioners consent to the removal of Mr. Larry Hendra as a member of the St. Luke's Hospital Board of Directors (Trustees) in accordance with procedures outlined in Articles of Amendment to the Hospital Charter as adopted on March 21, 1980." This was passed.
